6.3 Natalie Corona Scholarship Criteria Change

The Woodland Community College Fund Committee is recommending a change in the criteria for the Natalie Corona Memorial Scholarship. Leslie Deniz, Administration of Justice faculty as WCC explained the proposed change which would award a grant to a WCC Alumni/student to attend a police academy. That grant would not exceed \$7,500 and a special committee, including law enforcement personnel would be established to determine the recipient.

Motion was made to continue funding the annual \$500 scholarship to a WCC Student, and offer a grant, not to exceed \$7,500 for a WCC graduate to attend POST Academy, with the understanding it may not be funded annually. Motion Jessie Ortiz; Second by Marcia Stranix; Motion Passed Unanimously
