CONTRACTOR agrees to provide **FOUNDATION** the services enumerated in Section H of this Agreement under the following terms and conditions:

- A. Service shall begin on _____ and shall be completed on or before _____.
- B. In consideration for services performed by **CONTRACTOR** the **FOUNDATION** agree to pay **CONTRACTOR**: \$_____. Payment(s) shall be made based on invoice(s) submitted to **FOUNDATION** by **CONTRACTOR** and approved by Foundation representative.
- C. **CONTRACTOR** understands and agrees that he/she and all of his/her employees are not employees of the **FOUNDATION** and are not covered by benefits to which employees are normally entitled, including State Unemployment Insurance or Workers' Compensation.
- D. **CONTRACTOR** shall assume full responsibility for payment of all federal state, and local taxes or contributions including Unemployment Insurance, Social Security, and Income Taxes with respect to **CONTRACTOR's** employees.
- E. **CONTRACTOR** shall furnish, at his/her own expense, all labor, materials, equipment, and other items necessary to carry out the terms of this agreement, except for that provided by the **FOUNDATION**.
- F. In the performance of the work herein contemplated, **CONTRACTOR** is an independent contractor, with the authority to control and direct the performance of the details of the work, **FOUNDATION** being interested only in the results obtained.
- G. **CONTRACTOR** agrees to defend, indemnify and hold harmless the **FOUNDATION**, its Board of Directors, employees, and agents from any and all liability of loss arising in any way out of **CONTRACTOR's** negligence in the performance of the Agreement, including but not limited to any claim due to injury and/or damage sustained by **CONTRACTOR** and/or the **CONTRACTOR's** employees or agents.
- H. **CONTRACTOR** shall provide **FOUNDATION** with a Certificate of Insurance showing a minimum \$___ combined single limits of general liability and automobile coverages as required by the **FOUNDATION**.
- I. Services to be rendered to the **FOUNDATION** by the **CONTRACTOR** are as follows: _____

- J. Neither party shall assign or delegate any part of this Agreement without the written consent of the other party.
- K. The work completed herein must meet the approval of the **FOUNDATION** and shall be subject to the **FOUNDATION's** general right of inspection and supervision to secure the satisfactory completion thereof. **CONTRACTOR** agrees to comply with all Federal, State, Municipal, and District laws, rules, and regulation that are now, or may in the future become applicable to **CONTRACTOR**, **CONTRACTOR's** business, equipment, and personnel engaged in operations covered by this Agreement or accruing out of the performance of such operations.
- L. This agreement may be terminated by either party notifying the other, in writing, at least FIVE (5) days prior to the date of termination.
