Public Content

Background:

The Yuba Community College District Foundations Bylaws were last revised in August 2014. Section 4 of Article 7 of the bylaws is titled Advisory Committees and states that the Board may also establish College or campus based advisory committees composed of any number of directors and/or other interested persons who are not directors. Advisory committees shall provide advice and recommendations to the Board but shall not have the authority of the Board or any final decision-making authority, except as specifically delegated. Currently there are two established committees that are designated as Advisory Committees, the Woodland Community College Fund Committee and the Yuba College Alumni and Friends Committee. In addition, the Lake County Campus is in the process of organizing an Advisory Committee. While the bylaws allow for the

creation of advisory committees, they do not provide any structure for the operation of the committees, specifically related to membership, meeting and officers.

The proposed additions to the Foundations Bylaws add language under Section 4 of Article 7 to provide structure related to number and qualification of Advisory Board members, Vacancies on Advisory Committees, Advisory Committee meetings, Officers of Advisory Committees and their responsibilities. The proposed revisions are detailed in the attachment to this agenda item.

The proposed additions are being recommended by the Woodland Community CollegeFund Committee and are being submitted to the Foundation Board for a first review and discussion. The proposed timeline for approval of the proposed additional is at the February2024 regular meeting of the Foundation Board.

The proposed additionsmay be approved by a majority vote of the Board in accordance with Article XI: Amendments of the currently approved Boundation Bylaws. "Subject to any limitations in the Nonprofit Public Benefit Corporation Law, these Bylaws may be initially adopted, and thereafter amended, or repealed and new bylaws adopted, by a majority vote of the Board at any properly called meeting where a quorum is present, so long as the amendments, proposed repeal, or new bylaws are provided to each director at least three (3) days prior to the meeting at which such amendments, repeal, or new bylaws will be discussed and voted on.

Public Content

Background:

Section VII of Foundation Board Policy 2.0 governs the annual spending of the invested funds of the Foundation. The intent of the Spending policy is to create a measured long-termfocus of financial support for the Foundation that contemplates market conditions, net return, and a desire to grow the balance of the Fund. The targeted annual spending rate is 4.5 5.5% and will be determined using the average account value of the previous three fiscal years ending period (June 30) endowment values.

Status and Analysis:

It is recommended that the amount distributed for the 2023-24 year be **\$489,736**, 5% of the three-year average, and a \$11,576 increase over the 2022-23 distribution.
