Public Content

Background

At the June meeting of the Yuba Community College District Governing Board trustees voted to compensate student trustees, one representing Yuba College and one representing Woodland Community College, with the same stipend amount as elected trustees. Currently student trustees receive a stipend equal to 50% of the elected trustees stipend which is \$410.50 per month.

Since that meeting the Governing Board was made aware that the California Education Code requires that any change to the trustees stipend, must be made prior to May 15. As a result the District will not be able to use District Funds to increase the student trustees stipend until the next fiscal year.

Chancellor Houston has asked if the Foundation has resources that could be used to make up the difference between a student trustee current stipend, and what the Governing Board approved to increase their stipend to. That amount for the remainder of this fiscal year would be \$2,054 per student trustee for a total of \$4,108. Currently there is no student trustee for Woodland Community College so for every month that position is vacant the liability of \$4,108 would decrease by \$205.45.

The Foundation does have resources available in the Multi-College Progress Fund (\$11,364) and the Foundation Unrestricted Operating Fund (\$24,962) that we could use cover the increased stipend to the student trustees. To do so, would require a vote of the Foundation Board. The Director recommends that the Multi-College Progress Fund be used if the expense is approved.

Public Content

Background:

At the August 5, 2020 Foundation Board Meeting, one of the board members inquired about the negative balance in the Yuba College Student Services Fund. The balance of that fund on June 30, 2020 was a negative \$9,050. The Director said that he would come back with an explanation of thenegative balance, and include it as part of the Special Meeting.

At the August 6, 2013 meeting of the YCCD Foundation Board the Foundation Director reported that Yuba College was starting a Public Events Series and that the Foundation would be providing seed money for the project. It was reported that the Foundation would loan \$6,000 in the fall of 2013 and another \$12,000 in the spring of 2014, and that proceeds from the events would be used to pay back the foundation. The Directors Report from that meeting, along with the meeting minutes are attached. The minutes show that this was an informational item and does not indicate that the loan was an action item or even voted on by the Board. Katy Miller indicated that the loans were never made, although the College started the series and was charging expenses to the fund account.

At the end March of 2017, the balance of the fund was \$20,269 in the red. In June of 2017 the balance was brought to attention of Dr. Javaheripour. Since that time, the Colleges Marketing Director, has been working to get the fund back to even, but she has since retired. Since June of 2017 approximately \$11,219 of the deficit has been erased leaving a balance of \$9,050 as of June 30, 2020.

A detailed accounting of all income and expenses from 2013 to the present is being prepared and will be made available.

As the Foundation Director, I would recommend that the Foundation Director and the Yuba College President work together to develop a plan that will erased the remaining \$9,050 of the Student Services Fund deficit and provide annual updates to the Foundation Board on the progress of that plan.
