### **Program Purpose:**

The YCCD Employee Spotlight Program (ESP) is a recognition initiative designed to celebrate the unique contributions of CSEA employees across the District. By highlighting individual accomplishments, talents, and dedication, the program fosters a culture of appreciation, strengthens CSEA employee engagement, and promotes a deeper sense of belonging within the YCCD community.

#### Nomination Schedule:

Each year, nine (9) employees will be recognized at the designated Board meetings. The Offices of the College Presidents, the Chancellor, and the DSET Committee coordinate nominations. These entities each submit an Employee Spotlight agenda item following the established Board agenda timeline and the rotation schedule outlined below.

To make it possible for the nominated employees to attend in person the Board meeting when they are recognized by the Board, the nominees for the colleges will be invited, whenever possible, to the Board meetings that are scheduled at the specific college. Beginning in January 2026, the table below sets the rotation schedule among the two Colleges and the District Services.

#### **Selection Criteria:**

Nominees should exemplify one or more of the following:

- . Significant contributions to advance district and college missions
- . Exhibiting and living college and district values
- . Going above and beyond regular responsibilities
- . Leading a challenging initiative or project
- . Providing an innovative idea that results in solving problems or saving resources

### **Recognition and Reward**

Each spotlighted employee will receive:

- · A Certificate of Appreciation
- · A \$250 monetary award
- · Formal recognition and congratulations at the Board meeting

### **Funding Source**

Pending approval by the District Foundation Board, the Foundation will allocate \$2,250 annually from its endowment fund to support the ESP.
